Residential Treatment

TCC's Residential Treatment program provides 24-hour care for children who cannot function in a home environment. The residential staff helps the children resolve past traumas and develop new skills to manage emotions and solve problems. We also offer short-term stabilization services to children and families during a mental health or behavioral crisis in our Special Services Unit when an inpatient admission is not required.

Seven-year-old Ethan has had a rough childhood.

He witnessed and experienced a lot of aggression and abuse, instead of a safe and loving environment. As a result, he wasn't able to form strong attachments his first three years of life. This has led to behavioral issues involving anger and acting out. Ethan was removed from his home and has been in six foster homes because they have been ill-equipped to handle his aggressive behaviors. He acts out because he can't trust that the world is a safe place to live.

Ethan has been referred to TCC's Residential Treatment program by a county Department of Human Services. TCC is a consistent and predictable environment where the staff members care about the children. TCC is giving Ethan the help he needs so he can have a better life.

Tennyson Center Residential and Day Treatment staff are currently learning and implementing the Collaborative and Proactive Solutions model. This approach allows staff to identify specific cognitive skills where a child is lagging and then works to help the child and staff identify concerns when these lagging skills lead to challenging behaviors. In this model the adults and the child work together to identify solutions that are mutually satisfactory.

TCC's Residential Treatment program has five residential units, or cottages, with capacity for up to 60 children. Ethan has his own room, eats meals family-style with the other residents and hangs out in the living room. While living at TCC, Ethan goes to school in the onsite educational program. After school and on the weekends, Ethan participates in multiple groups that are focused on learning how to be safe, respectful and responsible. Ethan also plays with the other residents on the playground, travels to off-campus activities and visits with his TCC mentor.

The staff works with Ethan to help him regulate his emotions, build healthy attachments with adults and children, and learn how to be a trusting member of a group. After about nine months, Ethan has moved on to a foster home that loves him, cares for him and makes sure he is safe. He remains enrolled in Tennyson Center's Day Treatment program.



Day Treatment

TCC's Day Treatment program serves children who live at home but may need more individualized schooling as they recover from abuse or neglect, or they may have mental health or developmental issues. TCC operates a kindergarten through 12th grade school that is approved by the Colorado Department of Education and accredited by AdvancED, an accreditation that promotes the learning, growth and development of children. In 2014, TCC ran 11 classrooms for 212 students.

In addition to the onsite school, TCC runs a classroom in Clayton Elementary School in Englewood, Colo. The Clayton program serves children from kindergarten to sixth grade. One teacher, one therapist and two youth treatment counselors manage the classroom for up to nine children. TCC has been operating offsite locations for more than 10 years as a way to allow children to remain integrated in their communities.

TCC also offers the Innovative Direct Educational Assistance for Learners (IDEAL) program. IDEAL is an alternative education program coordinated with Denver Public Schools.

Ethan is progressing in his treatment, becoming more emotionally stable and living with his new family, yet he still needs support.

He attends school at TCC in order to continue learning how to be safe, how to manage his emotions and how to be in control of his words and actions with his peers.

He is in a class with seven other children. The students are learning math, reading and writing. Ethan also participates in art and computer classes, physical education, and social skills lessons.

Because TCC's Day Treatment program is integrated with therapy, Ethan meets one-on-one with his clinician, as well as receives group and family therapy with his foster parents.

During the summer months, Ethan will participate in TCC's eight-week summer school program and the Challenge-by-Choice program. This outdoor experiential education class will take him to the mountains to participate in activities such as camping, backpacking, rafting and other outdoor wilderness activities.

The average amount of time that students are in TCC's Day Treatment program is nine months. Ethan will transition to public school when he is equipped to have a good school experience.

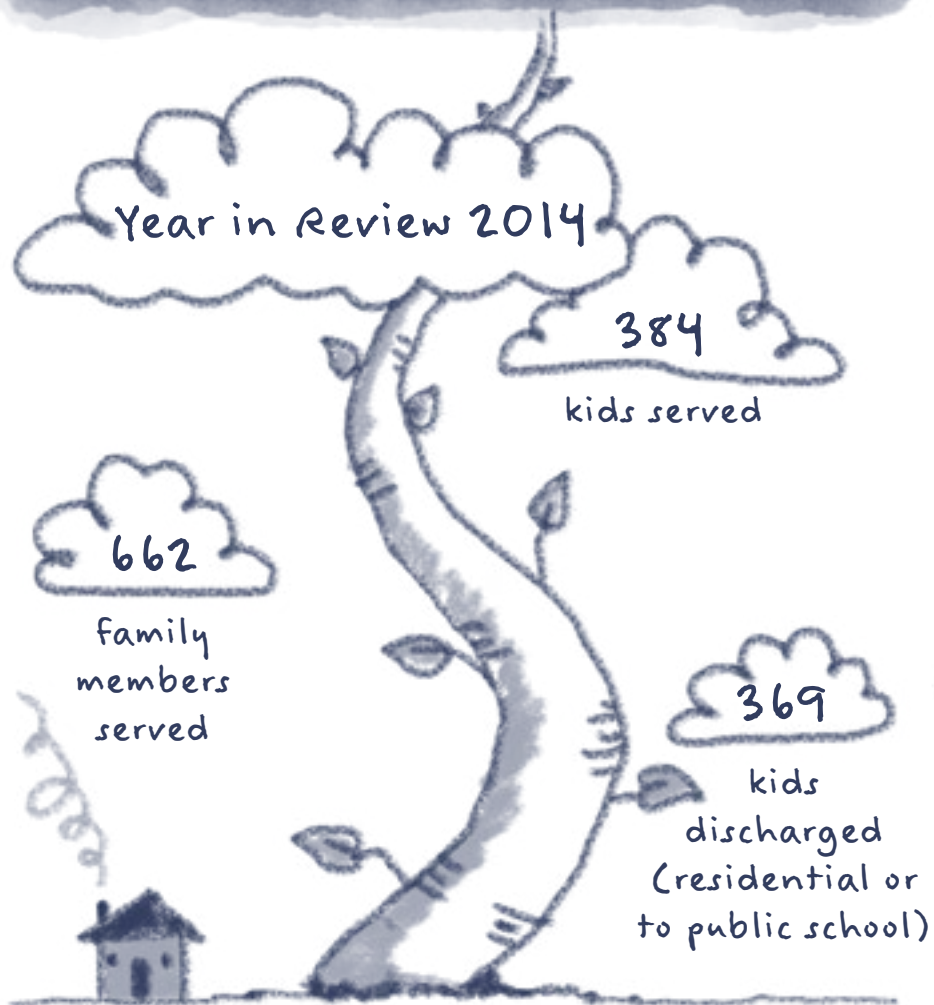


Community-Based Services

TCC's Community-Based Services (CBS) are intensive in-home programs providing therapeutic services in the child's home and community between two and 30 hours per week. This program serves the entire family and focuses on emotional and behavioral challenges, mental health concerns, case management, family preservation, reunification and preventing out-of-home placements. TCC's CBS team also offers bilingual, culturally relevant services to Spanish-speaking families.

When Ethan transitioned out of TCC's residential program into his foster home, the CBS team began providing therapy in the home to make sure Ethan's transition goes smoothly. The team created a treatment plan designed specifically for Ethan and his family focusing on therapy, support and coaching. The TCC team is helping the family with structure and organization as needed. They continue to reinforce a positive relationship between Ethan and his foster parents.

Ideally, the team will help Ethan and his foster parents create a trusting, consistent family unit.
